This packet will show you how to change your legal name and gender marker.

Part 1: Fill out your forms and file them with the clerk

- 4. Give the forms to the clerk's office to start your case.
- 5. Get your court hearing details from the clerk.

How to Fill Out Your Forms

How to Fill Out the Top Box (Caption)

The first page of each form has a box at the top. This is called the "caption." It tells the court who you are and what your case is about.

Look at the picture below to see what it looks like.

You will need to fill out the caption on every form. We'll show you what to write.

Here's what goes in each part:

- 1. County you are filing in
 - Write the name of the county where you are filing your forms.

Example: Marion

2. Case number

Leave this blank for now. The court will fill it in after you file your forms.

3. Current legal name

Write the name that is on your ID right now — this is the name you want to change.

TIP: You'll use the same information at the top of every form in your packet. Copy it the same way each time.



How to Fill Out the Rest of the Forms

Don't worry! You don't have to know legal words. Just answer honestly and clearly.

Form 1: Appearance by Self-Represented Person in Civil Case

(Telling the court you're representing yourself)

This form lets the court know that you're handling your case without a lawyer. Here's how to fill it out:

- Fill Out the Top Box (Caption)
 Go to page 2 of this packet for instructions.
- Line 1: Your Current Legal Name
 Write your full legal name first, middle, and last (this is the name you want to change)
- 3. Line 2: Your Contact Information
 Write the address where you want the court to send you mail. Also write your phone
 number and email address where the court can reach you.
- 4. Date Write the date you are signing this form.
- 5. Sign The Form A Sign your name using your current legal name.
- 6. Print Your Name
 Print your current legal name clearly.

You're done with this form. Great job! Now you're ready for Form 2.



Form 2: Verified Petition for Change of Name and Correction of Birth Certificate

(Asking the court to change your name and gender marker.)

This form tells the court what you want to change – your name and gender marker. Here's how to fill it out:

1. Fill Out the Top Box (Caption)

Not sure what to put? Go to page 2 of this packet — it explains the caption box.

2. Petitioner,

Print your current legal name clearly on the line.

3. Line 1: Your Current Legal Name

Write your full legal name — first, middle, and last (this is the name you want to change).

4. Line 2: Your Date of Birth

Write your full date of birth (month, day, year).

5. Line 3: Your Residential Address

Write the address where you live right now.

6. Line 4: Your Mailing Address

Write the address where you want to get mail — if it's the same as your residential address above, you can copy it here.

7. Line 5: Your Driver's License/ID Card Number

Check one box:

- If you have an Indiana driver's license or ID, check the first box and write the number.
- ☐ If you do not have one, check the second box.

8. Line 6: Your Past Legal Names

Check one box:

- If you have never changed your legal name before, check the first box.
- If you've had other legal names in the past, write each one here (first, middle, and last).

9. Line 7: State You Were Born In

Write the name of the state where you were born.

Example: Indiana

Keep going! You're almost done with this form.

Form 3: Order Setting Hearing

This form is for the court to set the date of your hearing. Here's how to fill it out:

- Fill Out the Top Box (Caption)
 Use the same county and name you wrote on the other forms.
 Not sure what to put? Go to page 2 of this packet it explains the caption box.
- Leave the Rest Blank
 You don't need to fill out the bottom part.
 It's for the Judge to fill out and sign.

You're done with this form. Great job! Now you're ready for the next forms.



Form 4: Order on Change of Name

This form is the court's official order to change your name.

Here's how to fill it out:

- 1. Fill Out the Top Box (Caption)
 - Use the same county and name you wrote on the other forms. Not sure what to put? Go to page 2 of this packet it explains the caption box.
- Line 2: Your Date of Birth Write your full date of birth (month, day, year).
- 3. Line 3: Your Current Legal Name
 Write your full legal name first, middle, and last (this is the name you want to change).
- 4. Line 4: Your Past Legal Names
 - If you've never had another legal name, write "N/A".
 - If you've had other legal names, write each one here (first, middle, and last).
- 5. Your New Legal Name: Petitioner's Legal Name is Changed To Write the full new name you want first, middle, and last.
- 6. Birth Certificate Name Change: Petitioner's Birth Certificate Changed To Check one box:
 - If you want to change your name on your birth certificate to your new legal name, check "Be changed to" and write your full new name.
 - ☐ If you do not want to change the name on your birth certificate to your new legal name, check "Not be changed".
- 7. Leave the Rest Blank

You don't need to fill out the bottom part. It's for the Judge to fill out and sign.

You're done with this form. Great job!



Form 5: Order on Correction of Birth Certificate

This form is the court's official order to change your gender marker.

Here's how to fill it out:

Fill Out the Top Box (Caption)
 Use the same county and name you wrote on the other forms.
 Not sure what to put? Go to page 2 of this packet — it explains the caption box.

- 2. Line 2: Your Date of Birth Write your full date of birth (month, day, year).
- 3. Line 3: Your Current Legal Name
 Write your full legal name first, middle, and last (this is the name you want to change).
- 4. Line 4: Your Past Legal Names
 - If you've never had another legal name, write "N/A".
 - If you've had other legal names, write each one here (first, middle, and last).
- Correct Gender Marker: Petitioner's Legal Sex/Gender Designation is Changed to Write the correct gender marker for your birth certificate.
 Options: male, female, or nonbinary
- 6. Leave the Rest Blank
 You don't need to fill out the bottom part.
 It's for the Judge to fill out and sign.

You're done with this form. Great job. Now you're ready to review instructions for the filing fee and keeping your case private.



2. Review the filing fee information

• It costs \$157 to start your case in court. If you cannot afford this fee, you can ask the judge to remove it.

Do I need to fill out the fee waiver forms?

You need to fill out the fee waiver forms:

Form 6: Verified Motion for Fee Waiver

Form 7: Order on Fee Waiver

→ Page 11 has step-by-step instructions to help you fill out the fee waiver forms.

You can skip the fee waiver section. You don't need the fee waiver forms. Go ahead and take them out of your packet.

Court filing fees can be paid in different ways: cash, money order, credit/debit card.

Form 6: Verified Motion for Fee Waiver

(Asking the court to remove the \$157 filing fee)

This form tells the court about your money situation. The judge will use this form to decide if you need to pay the \$157 filing fee or not. Here's how to fill it out:

1. Fill Out the Top Box (Caption)

Use the same name and county you wrote on the other forms. Not sure what to put? Go to page 2 of this packet — it explains the caption box.

2. Petitioner,

Print your current legal name clearly on the line.

3. Lines 3 through 8: Your Financial Information

Write how much money you make (income) and how much you spend each month (expenses).

Answer every question as honestly as you can.

4. Date

Write the date you are signing this form.

5. Sign The Form A

Sign your name using your current legal name.

6. Print Your Name

Print your current legal name clearly.

TIP: If anything doesn't apply to you, write "N/A," which means "not applicable."

Form 7: Order on Fee Waiver

This form is the court's official decision about your fee waiver request. Here's how to fill it out:

1. Fill Out the Top Box (Caption)

Use the same county and name you wrote on the other forms. Not sure what to put? Go to page 2 of this packet — it explains the caption box.

2. Leave the Rest Blank

You don't need to fill out the bottom part. It's for the Judge to fill out and sign.

You're done with these forms. Great job! Now you're ready to learn about keeping your case private.



3. Review Keeping Your Case Private

When you ask the court to change your name, the law requires:

- Publishing your name change in a newspaper
- Making your court records public online

When you ask the court to change your gender marker, the law requires:

Making your court records public online

But — you can ask the judge to make your case private and remove the newspaper publication requirement to help keep you safe.

Common reasons to ask to keep your court records private:

- You are transgender and feel unsafe being outed
- You have survived domestic or family violence, and you're afraid of someone finding your new name or address

Do I need to fill out the privacy forms?

☐ Yes: I'm worried that having my court records public and publishing my name change in a newspaper could be a risk of harm

You should fill out the privacy forms (called ACR Request forms):

- → Pages 13 and 14 have step-by-step instructions to help you fill out the privacy forms.

☐ No: I feel safe having my case be public.

You don't need the privacy forms. Go ahead and take them out of your packet. Instead, fill out this form next:

- Form 12: Notice of Petition for Change of Name
- → Page 15 has step-by-step instructions to help you fill out the notice form.



Privacy Forms Instructions - Form 8, 9, 10, and 11

Form 8: Verified Request to Prohibit Public Access (ACR Request)

(Asking the court to keep your case private)

This form asks the judge to:

- Keep your court records private
- Waive the requirement to publish your name change in the newspaper
- Review why you're asking for privacy (for example, for safety or privacy reasons)

Here's how to fill it out:

1. Fill Out the Top Box (Caption)

Use the same name and county you wrote on the other forms.

Not sure what to put? Go to page 2 of this packet — it explains the caption box.

2. Petitioner,

Print your current legal name clearly on the line.

3. Date

Write the date you are signing this form.

4. Sign The Form A

Sign your name using your current legal name.

5. Print Your Name

Print your current legal name clearly.

Form 9: Public Notice of Hearing

This form lets the public know that you are asking the court to keep your case private. It's only posted at the courthouse, not in a newspaper.

Here's how to fill it out:

1. Fill Out the Top Box (Caption)

Use the same county and name you wrote on the other forms.

Not sure what to put? Go to page 2 of this packet — it explains the caption box.

2. Leave the Rest Blank

You don't need to fill out the bottom part.

It's for the Judge to fill out and sign.



Form 10: Interim Order on ACR Request

This form asks the judge to keep your case private until your court date. Here's how to fill it out.

- Fill Out the Top Box (Caption)
 Use the same county and name you wrote on the other forms.
 Not sure what to put? Go to page 2 of this packet it explains the caption box.
- Leave the Rest Blank
 You don't need to fill out the bottom part.
 It's for the Judge to fill out and sign.

Form 11: Order on ACR Request

This is the judge's official order to make your case private. Here's how to fill it out:

- Fill Out the Top Box (Caption)
 Use the same county and name you wrote on the other forms.
 Not sure what to put? Go to page 2 of this packet it explains the caption box.
- Leave the Rest Blank
 You don't need to fill out the bottom part.
 It's for the Judge to fill out and sign.

You're done with the forms!!! Now you're ready to file your case with the clerk.

You don't need Form 12: Notice of Petition for Change of Name. Go ahead and take it out of your packet.

→ Go to Page 16 for step-by-step instructions on how to file.



Form 12: Notice of Petition for Change of Name

(Publishing your name change in a newspaper.)

You need to put an ad in a newspaper about your name change. This form has the information to put in the ad.

Here's how to fill it out:

- Fill Out the Top Box (Caption)
 Use the same county and name you wrote on the other forms.
 Not sure what to put? Go to page 2 of this packet it explains the caption box.
- Leave the Rest Blank
 You don't need to fill out the bottom part.
 It's for the county clerk to fill out after you file your forms.
- → Instructions for placing the newspaper ad are in **Part 2** of this packet.

You're done with the forms!!! Now you're ready to file your case with the clerk.

→ Go to Page 16 for step-by-step instructions on how to file.



4. Give the forms to the clerk's office to start your case

- Bring all the forms from **Part 1** that apply to you.
- If you're paying your court filing fee, bring your fee payment too.

5. Get your court hearing details from the clerk

My Case Information:

- The clerk will tell you details about your court hearing when you start your case, or later by phone, by mail, or by email.
- After filing, check your email, mail, and voicemail often for updates from the court. If
 you don't hear from the clerk within 3 weeks after filing your case, call the clerk to
 ask about the status of your hearing.

Part 2: Get ready for court and get the Judge's decision

Part 2 Things to Do

- 1. Place an ad in the newspaper for changing your name [Only if your case is public.]
- 2. Collect your documents for your court hearing.
- 3. Get ready for your court hearing.
- 4. Talk to the Judge and get a decision

Instructions:

1. Place an ad in the newspaper for changing your name [Only if your case is public.]

- Skip this section if you asked the court to keep your case private.
- You need to place an ad in a local newspaper as soon as you can. The ad must run
 once a week for three weeks, and the last ad must run at least 30 days before your
 hearing.
- When you filed your case, the clerk stamped your "Notice of Petition for Change
 of Name". This is the information you will use for the newspaper ad. Contact one of
 your local newspapers to place the ad.
- After you place the ad, the newspaper should send you proof that it was published.
 Keep this proof and give it to the Judge at your hearing.

2. Collect your documents for your court hearing

- Bring these documents to court that apply to you:
 - State photo ID, if you have one
 - Original or certified copy of your Birth Certificate
 - US Passport, if you have one
 - Proof of your previous names (like marriage certificates, divorce decrees, or name change documents)
 - Proof that your name change ad was published in the newspaper (only if your case is public)



- For Marion County: You will receive the "Order for Documents." This is given to everyone. If you asked to keep your court records private (the ACR6 Request), the Order tells you that you do not need to publish anything in the newspaper before your hearing. If you are only asking for a gender marker change, you also do not need to publish anything before your hearing. If your case is public, the Order reminds you to place an ad in the newspaper before your hearing. Follow the other instructions in the Order and collect the documents, if you have them. Then bring the documents to your court hearing.
- There is NO requirement for medical information or surgery. Some judges may
 ask about your medical history. You do not have to share any medical information. If
 you are not comfortable telling the court private medical details, just let the judge
 know.

3. Get ready for your court hearing

- Going to court can feel scary, but most name and/or gender marker change cases are quick and easy. Here are some common questions about the court hearing:
 - What should you wear? Wear something that isn't too casual, but also makes you feel comfortable and confident. You can't wear hats in the courtroom.
 - What to expect when you first get to court? In many courts, you must go through security. The lines can be long, so try and arrive at least 15 minutes before your hearing. Make sure you are on time for your hearing. If you arrive late, the judge may reschedule your hearing for another date.
 - Finding your courtroom. If you don't know where the courtroom is, ask a security guard or court worker for help. When you find your courtroom, go to the court office and let them know you are there for your hearing. The court worker will tell you where to wait. Then, take a seat and wait for your turn.
 - Video hearings. Download the software a few days before your hearing. After it is installed, test it out to make sure it works. On the day of your hearing, find a quiet place with good internet connection. Join your video hearing about 5 minutes before it starts. After you login, you will wait for the court to let you into the virtual hearing room. Sometimes the Judge is behind schedule, so you may be let in after your scheduled hearing time.
 - What name and pronoun will the judge use? The court case is listed under your old name, but some judges try not to use your old name or pronouns. Some



judges may ask what your pronouns are. Other judges might not think about it and will use your old name.

4. Talk to the Judge and get a decision

• When it is your turn, someone from the court will call your legal name. They will tell you where to sit, and the hearing will begin. You will swear to tell the truth, and then the Judge will ask you questions.

If you asked to keep your court records private (ACR Request):

- Tell the judge about why you would face a "big risk of harm" if your name change were published in the newspaper and if your name and/or gender marker change were posted on the court website.
- Explain why you would feel unsafe if your transgender identity and contact information were made public. Share any experience of violence or discrimination you have faced because of your gender identity, or any stories of violence that you have heard about transgender people facing. This will help the judge understand why it's unsafe for your information to be shared publicly.
- After the Judge finishes asking questions, they will tell you if your ACR Request is granted. Some judges may decide your ACR Request and then schedule a second hearing for your name and/or gender marker change request. Most judges will handle both requests at the same hearing.

If you published in a newspaper:

Give the Judge proof that your name change was published in a newspaper.

The Judge will ask you questions about your name and gender marker change.

- You need to show the judge that you are who you say you are, and the law lets you change your name and gender marker. To do this, show the Judge your ID and birth certificate, and tell them that the information in your legal paperwork is true.
- You should also tell the Judge about why you are changing your name and gender marker. You should explain that you want your name and gender marker



to match who you are and explain that you are not changing your name to avoid the police or debts.

- After the Judge is done asking questions, they will tell you if your name and gender marker is changed. Sometimes, the judge may not decide right away because they need more information (for example, if you forget to bring your ID or birth certificate).
- If your name and/or gender marker change is approved, the Judge will let you know if you can get official copies of your court order after the hearing, or if you need to come back another day to get them.

Part 3: Change your IDs after court

Part 3 Things to Do:

- 1. Get certified copies of your name and/or gender marker change court orders.
- 2. Update or get new IDs with your new name and/or correct gender marker.

CONGRATULATIONS! The judge has signed the court order that legally changes your name and/or gender marker.

Instructions

1. Get certified copies of your name and gender marker change court orders

- To use the court orders to update your IDs, you need to get certified copies. A
 certified order has a special stamp that shows it is an official court document.
- To get certified copies, go to or contact the clerk's office the same office where you started your case. The cost is usually **\$2 per page**. You should get **3-5 copies**.

2. Update or get new IDs with your new name and/or correct gender marker

- Updating IDs requires paperwork and different rules for each ID. Each place that issues an ID has its own rules for name and/or gender marker changes. We've included a guide with instructions and forms for updating the following:
 - Social Security Card
 - Indiana driver's license or ID
 - Birth Certificate
 - US Passport
 - Voter Registration
- We also recommend updating your name with your banks, credit cards and credit reporting agencies. You can find a guide to updating your name with credit reporting agencies at https://www.nerdwallet.com/article/finance/how-trans-and-nonbinary-people-can-change-names-on-credit-reports.

under Rule 6 of the Indiana Access to Court Records Rules ("A.C.R."). In support, Petitioner states:

- I am seeking to change my name and correct the sex/gender designation on my birth certificate because I want my identity documents to accurately reflect my gender and presentation.
- 2. I am requesting, under Rule 6 of the Indiana Access to Court Records Rules (A.C.R.), that the Court keep this case confidential and waive the publication requirements of Ind. Code § 34-28-2-3.
- 3. I am making this request to avoid harm from publicizing my case, and to protect my privacy, safety, and confidential health information.
- 4. Based on my awareness of the high rates of violence and discrimination against transgender and gender non-conforming people in Indiana and nationwide, I believe that having to publish notice and having my case publicly available on the Court's electronic case management system puts me at substantial risk of harm and presents a significant risk that I could be targeted by acts of discrimination or violence based on my gender and/or by being outed as transgender.

- 5. FBI crime data shows that the number of recorded hate crimes against transgender people continues to rise, increasing from 307 gender identity-based incidents in 2021, to 515 in 2022, to 547 in 2023. Ct. App. 2017); *In Re M.E.B.*, 126 N.E.3d 932 at 934 (Ind. Ct. App. 2019); *In Re K.H.*, 127 N.E.3d 257 (Ind. Ct. App. 2019); *In re Name & Gender Change of R.E.*, 142 N.E.3d 1045 (Ind. Ct. App. 2020).
- 12. A.C.R. Rule 6 requires judges to evaluate if a substantial risk of harm exists under the totality of the circumstances and to proactively protect applicants' safety. Rule 6 does not require that Plaintiff endure targeted threats, violence, or abuse before granting temporary and permanent sealing and a publication waiver. *E.g. In Re M.E.B.*, 126 N.E.3d 932 at 934 (Ind. Ct. App. 2019).
- 13. There are no other parties or interested persons to this action.

WHEREFORE, Petitioner respectfully requests that, under Access to Court Records Rule 6 and 5, this case be excluded from public access by sealing the record of this proceeding and by waiving the publication requirements of Indiana Code § 34-28-2-3(a).
